Social Reformation In Odisha: An Alternative Vision

APPROPRIATE FIELDS OF SOCIAL REFORMATION

CORRUPTION: When corrupt people lead the aristocracy, when public salutes them, the public themselves define corruption. When the society is on the verge of political, social and financial catastrophe, the liberty is at a stake. Corruption dominates our bureaucracy, legislature, ballot box and even judiciary. Power politics is the breeding place of corruption. Power tends to corrupt and absolute power corrupts absolutely. Our vicious ambience best justify our mutual aid to fight corruption. Reluctance for this co- operation over a good span of time, conceives extremists who feel themselves responsible towards the revival. They feel them as gadflies who presume to awaken the unreasonably complacent society. The synergy of the co-operation of conscious and dedicated citizens may be tuned up to play the role of contraceptive when small social exploitations loom into a big group of extremists.

A group of intellectuals can go a long way in the direction of the solution. In Odisha mitigation of corruption can be achieved easily if the Chief Minister gives a strong support to an executive group. A few leading personalities of the state may introduce and fix up the strategy. With the support of Vigilance D G, Home Secretary and Chief Secretary a completely independent public intelligence cum information system will be activated. Minimum of ten intellectuals will take the vow to eradicate corruption. It is no less than any espionage work with awaiting martyrdom at every bent. Telephones will be tapped, close circuit cameras will be vigilant and some discussions will be recorded by FM microphones to keep track of corrupt movements. Eradication of corruption is not impossible. It is existent in our society only because till date no group of at least ten capable dedicated intellectuals have tried to take up the mission.

CO-OPERATIVE AND AGRICULTURE: Jungle Rule states as, "Fittest to survive". In reference to animals if we ask ourselves: "Who are the fittest: those who are continually at war with each other or those who support one another?" We at once see that those animals which acquire habits of mutual aid are undoubtedly the fittest. They have more chances to survive, and they attain, in their respective classes, the highest development of intelligence and bodily organization. Collective effort of a group of people can do miracles. In Odisha preferably co-operative should be implemented to encourage financial up gradation of rural people. Their agriculture, cottage industry, market and credit system should be assisted by mutual aid. In our state, co-operative was long since existent as KOTHA. A state level co-operative movement named as Kotha Andolan should be initiated by conscious citizens. It will be a non-political activity with support from all political parties. All intellectuals, Government and private employees should be involved and supposed to take up the responsibility for success by themselves.

In a state like Odisha agriculture and co-operative movement should be given priority over industrial development. In a sustainable movement we should first of all acquire our bread and butter. Agrobased industries should be established. co-operative, agriculture, agriculture allied, agro based industry, cottage industry, rural market and micro credit put together will comprise a single package intending for rural financial progress.

When power politicians are custodians of our liberty, everybody in the Bar Council love a conflict approaching them to take shape as a grown up admitted case, yielding a guaranteed income over a longer period and justice has been allowed to be bargained at the law shops. Nobody takes an initiative to extinguish the fire at its very beginning. Nobody has got the time and nobody is expected to be paid for it. Here comes the need for laying foundation stone and establishing a local court for the people, by the people and of the people, as a machinery to handle every conflict or breach before it moves to the police or the court. Mission 'Lok Adalat' will conduct local courts with local judges, juries, advocates and own tailor-made law and tradition.

Law is nothing but strong common sense. The law is reason free from passion. Law is an ordinance of reason for common good, made by him who has care of the community. With this vision, a local guardian, impartial and a well wisher of everybody should be selected by a group of conscious citizens and must be conducted to the chair with due esteem and faith. 'Panch Parameswar' of a village or five persons from the civil society of a township are to support the local justice or magistrate. He should have links with higher courts, legislatures as well as the media. Maintaining a upward linkage will make him more effective, efficient and updated to solve a breach at its bud and uphold the justice in his surroundings. His remuneration should come from a recommended, reasonable and undisputed source.

People will establish their own court. But well before that they should prepare the pitch, the ground to which our honorable justice will be conducted. Fellow feelings, mutual aid, social functions and interaction regarding different issues should be activated before the mission 'Lok Adalat' comes into effect. Individualistic and self centered attitude should be discouraged. Right environment is the

precondition for all types of wellbeing. How can one cut a caper with his lover in a stormy night? The pitch should be prepared well before the match takes place. Then only the audience can enjoy the courage, pep, spirit, bounce and the win at the end. Joint family concept, community responsibility and collective efforts are the foundation stones on which four columns of our democracy can be erected. These are also the prerequisites for a society of liberty and justice for all.

Our Government ignores this statistics only because they earn profound amount of revenue from Excise division. More NGO programmes, social activists' activities and co operation from political leaders are expected to immune the mass from converting into addicted idiots. Regular research has to be continued to find out the suitable circumstances which will in general discourage people from addiction. Precious human life from birth till death has to be nourished properly to be more virtuous, intelligent, efficient, creative, innovative, professional, generous, and spiritual which can be relayed to the next generation imparting more advanced genes to foster the evolution process. But being addicted their brain becomes defunct and stagnant. Instead of transforming into an intellectual, they define themselves as imbecile self centered scamps. Dedicated political cadres should arrange and specify their remunerations ranging from Rs 1,000/- to Rs1,00,000/- so that they won't expose their appetite in the face of corruption. Proper regulation of constructive and destructive power will again rotate the stagnant earth on the track of evolution.
